



**NOTICE OF PUBLIC MEETING

It has been brought to the attention of the City Clerk that the Neighborhood and Family Services Commission meeting agenda for the November 28, 2018 Regular Meeting was not properly posted in accordance with open meeting law due to an administrative error. Therefore, the commission inadvertently acted in violation of open meeting law.
